- No more than \$1,000,000 of annual payroll
- No work at a height over three stories
- Subcontracted work cannot exceed 25% of annual gross sales
- No General Contractors
- No renting or leasing of equipment to others
- Sales unrelated to installation, service or repair cannot exceed 25% of annual gross sales

Limited Cooking

- Definition: Foods are prepared cold or cooked using appliances which do not admit smoke or grease-laden vapors that require an exhaust system
- No open grilling, deep fat frying, roasting, barbecuing or solid fuel cooking
- No 24-hour operations (open after 11:00 PM)
- Limited coverage for Frame construction - no building coverage, limited contents

Additional Eligibility Requirements:

- No more than 7,500 square feet in total floor area
- Seating capacity no greater than 75
- With or without table service
- Sales of beer & wine only, no greater than 25% of total sales
- No bar or cocktail lounge
- Catering away from premises not to exceed 10% of total sales
- No seasonal operations (closed for more than 30 consecutive days)
- No food trucks
- No converted dwellings
- No entertainment or play areas

- Limited coverage for Frame construction – no building coverage, limited contents, no open grilling, deep fat frying, roasting, barbecuing or solid fuel cooking

Additional Eligibility Requirements:

- No more than 7,500 square feet in total floor area
- Seating capacity no greater than 75
- No table service
- Sales of beer & wine only, no greater than 25% of total sales
- No bar or cocktail lounge
- Catering away from premises not to exceed 10% of total sales
- Installation & maintenance of an automatic extinguishing system for cooking equipment
- No seasonal operations (closed for more than 30 consecutive days)
- No food trucks

- Take-out service & the use of a buffet may also be available
- No 24-hour operations (open after 11:00 PM)
- Limited coverage for Frame construction – no building coverage, limited contents, no open grilling, deep fat frying, roasting, barbecuing or solid fuel cooking

Additional Eligibility Requirements:

- May serve alcoholic beverages, beer, wine, and liquor with sales not exceeding 50% of total sales
- No more than 15,000 square feet in total floor area
- Seating capacity no greater than 150
- Catering away from premises not to exceed 10% of total sales
- No seasonal operations (closed for more than 30 consecutive days)

- No entertainment or dancing other than incidental music provided by the establishment
